HB 2088-Municipalities; sprinkler systems, residential housing; changes. Final action in House Monday 107-14. House members voting NO were - **Nays: Carlin, Davis, S. Gatewood, Kuether, Loganbill, Mah, McCray-Miller, Moxley, Peterson, Ruiz, Trimmer, Wetta, Winn, and Worley.** I sent an email to each of these representatives thanking them for voting NO and supporting “home rule”.
